6. A copy of this resolution and affidavit shall be sent to the State Auditor and the Public Education Department at least thirty days prior to the disposition of the property.
7. Once disposed of, the property shall be deleted from the School's official inventory.
8. The Interim Superintendent shall take such actions as are necessary to carry out the mandates of this resolution. The three-member committee appointed by the Interim Superintendent shall oversee the disposition of obsolete, worn-out or unusable tangible personal property.
